CITY OF BATTLE CREEK, MICHIGAN
PASSAGE OF ORDINANCE**

PLEASE TAKE NOTICE THAT the Battle Creek City Commission adopted the following ordinances:

Ordinance 01-2024, amending Sections 04, 05, 075, and 19 of Chapter 294, "General Personnel Regulations," by making changes to reference updated City Manager policies, to eliminate an obsolete employee performance evaluation program, and to comply with state law regarding employee residency. (February 20, 2024)

Ordinance 02-2024, amending the Zoning Code of the City of Battle Creek. (April 2, 2024)

Ordinance 03-2024, to rezone various properties located in two clusters along Michigan Avenue W, Jackson St. W, Kendall St. S, Van Buren ST. W and Angell St, currently zoned R-3, Multiple Family Residential District and T-3, Neighborhood Commercial District to T-4 Downtown Commercial District and T-3 Neighborhood Commercial District. (April 2, 2024)

Ordinance 04-2024, to amend the Historic Preservation Code of the City of Battle Creek. (April 16, 2024)

Ordinance 05-2024, to amend Sections 1, 3, 5, 6 and 99 and repeal Sections 4 and 98, of Chapter 1610 of City Ordinances, International Fire Code and to comply with State law and regulations. (May 14, 2024)

Ordinance 06-2024, to amend Chapter 286 "Police/Community Relations Advisory Committee," by repurposing it as the "Community Oversight Board," with the primary function to provide input, in an advisory capacity, to the City Manager in reconsidering the Police Chief's determination following a Community Relations Complaint investigation filed pursuant to the Police Department Policy. (May 14, 2024)

Ordinance 08-2024, amending Section 06 of Chapter 294 of City Ordinances, "General Personnel Regulations," by making changes to "Other Leaves of Absence" for consistency with City Policies and to align the bereavement leave with represented employee agreements. (June 4, 2024)

Ordinance 10-2024, amending Section 08 of Chapter 882 Real Estate Taxation, by updating the terms of the Payment in Lieu of Taxes (PILOT) to reflect the new ownership and financing of "Westbrook Place." (July 16, 2024)

Ordinance 11-2024, amending the Zoning Code for the City of Battle Creek. (July 16, 2024)

Ordinance 12-2024, amending the Chapter Title, as well as Sections 01, 02, 04-06, 08, 09, and 99 of Chapter 694 "Youth Offenses" by making it consistent with state law, replacing outdated statutory references, and ungendering language. (July 16, 2024)

Ordinance 13-2024, amending Sections 02, Articles X and XVII of Chapter 212, "Rules of Procedure of the Commission," regarding Public Comment to ensure a better flow to the Business Meeting. (September 3, 2024)

Ordinance 15-2024, amending chapter 882 "Real Estate Taxation" by amending Section 23, modifying the terms of a Payment in Lieu of Taxes for the Housing Development to be known as "Station Side Lofts." (September 23, 2024)

Ordinance 16-2024, amending chapter 882 "Real Estate Taxation" by amending Section 22, modifying the terms of a Payment in Lieu of Taxes to Northern Pines Apartments previously approved on October 17, 2023. (September 23, 2024)

Ordinance 17-2024, amending chapter 882 "Real Estate Taxation" by amending Section 24, modifying the terms of a Payment in Lieu of Taxes for the Housing Development to be known as "Manchester Place." (September 23, 2024)

Ordinance 18-2024, amending Section 290.07 Longevity Plan, of the Battle Creek Code of Ordinances. (December 3, 2024)

Ordinance 01-2025, amending Section 21 of Chapter 882 Real Estate Taxation, by amending the terms of the Payment in Lieu of Taxes (PILOT) to reflect restructuring for the "Blue Light Redevelopment Project." (March 4, 2025)
